AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 2 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0205 REGARDING THE PROCEDURE FOR ZONING COMMENCEMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 2 of the San Diego Municipal Code be amended by amending Section 101.0205 to read as follows:

SEC. 101.0205 PROCEDURE FOR ZONING COMMENCEMENT

The inclusion or placing of property in a zone or a proposed change of zone may be initiated by the Planning Commission or the City Council or by a verified application by one or more of the owners of the property to be zoned or rezoned. Said application to zone or for change of zone shall be filed with the Planning Commission in the office of the Planning Department upon a form and accompanied by such data as may be prescribed for that purpose by the Planning Commission.

No application, from one or more owners of property, for zoning or rezoning the same property or essentially the same parcel of land, which has been denied by the City Council, shall be accepted by the Planning Commission within 12 months of such denial.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
