AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0511 RELATING TO CONDITIONAL USE PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5 of the San Diego Municipal Code be amended by amending Section 101.0511 to read as follows:

SEC. 101.0511 RESTRICTION ON REAPPLICATION FOR A CONDITIONAL USE PERMIT

No application for a conditional use permit on the same property or essentially the same property, the same use or essentially the same use which has been denied by the Zoning Administrator, the Board of Zoning Appeals, the Planning Commission or the City Council shall be accepted within 12 months of such denial.

Section 2. This ordinance shall take effect and be it force on the thirtieth day from and after its passage.
