BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:


Section 1. That Chapter X, Article 1, Division 9 of  
the San Diego Municipal Code be amended by amending  
Section 101.0910 to read as follows:

SEC. 101.0910 PLANNED COMMERCIAL DEVELOPMENTS  
[No amendment to subsections A through S.]

T. No application for a planned commercial  
development permit on the same property, or essentially  
the same property, for which a permit has been denied  
by the Planning Director, or Planning Commission, or  
City Council, shall be accepted within twelve (12)  
months of such denial.

Section 2. This ordinance shall take effect and be  
in force on the thirtieth day from and after its passage.
