AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,
DIVISION 9 OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 101.0920 RELATING TO
PLANNED INDUSTRIAL DEVELOPMENT PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter X, Article 1, Division 9
of the San Diego Municipal Code be amended by amending
Section 101.0920 to read as follows:

SEC. 101.0920 PLANNED INDUSTRIAL DEVELOPMENTS
[No amendment to subsections A through S.]

T. No application for a planned industrial
development permit on the same property, or essentially
the same property, for which a permit has been denied
by the Planning Director, or Planning Commission, or
City Council, shall be accepted within twelve (12)
months of such denial.

Section 2. This ordinance shall take effect and be
in force on the thirtieth day from and after its passage.
