AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY TRANSFERRING WITHIN THE GENERAL FUND 100, DEPARTMENT 023, THE SUM OF \$10,100 FROM OTHER PERSONNEL EXPENSE [O/A 2102 - \$8,300 AND O/A 2202 - \$1,800] TO MATERIALS AND SUPPLIES [O/A 3298 - \$10,100].

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-2 by transferring within the General Fund 100, Department 023, the sum of Ten Thousand One Hundred Dollars (\$10,100) from Other Personnel Expense to Materials and Supplies as follows:
