AN ORDINANCE INCORPORATING PARCEL A, BLOCK 2 AND LOTS 27-31, BLOCK 5, LA JOLLA STRAND, MAP NO. 1216, WEST OF I-5 AND GENERALLY BOUNDED BY COAST BOULEVARD ON THE NORTH AND COLIMA STREET ON THE SOUTH, IN THE LA JOLLA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CC ZONE, AS DEFINED BY SECTION 101.0427 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11167 (NEW SERIES), ADOPTED NOVEMBER 27, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel A, Block 2 and Lots 27-31, Block 5, La Jolla Strand, Map No. 1216, west of I-5 and generally bounded by Coast Boulevard on the north and Colima Street on the south, in the La Jolla Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CC" on Zone Map Drawing No. C-644.1, be, and it is hereby incorporated into CC Zone, as such zone is described and defined by Section 101.0427 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11167 (New Series), adopted November 27, 1973, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
