AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0426 REGARDING THE CN ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4 of the San Diego Municipal Code is hereby amended by amending Section 101.0426 to read as follows:

SEC. 101.0426 CN ZONE (NEIGHBORHOOD COMMERCIAL)
