WHEREAS, Executive Services Department (011) is presently authorized two (2) Administrative Secretary positions; and

WHEREAS, a review of the positions indicates the nature and duties are more consistent with the classification of Council Representative II; and

WHEREAS, Section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission has reviewed this request on August 7, 1980, and commented favorably upon the reclassification and exemption; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said reclassification; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-1, as adopted and amended therein, by reclassifying within the personnel authorization schedule of Department Oll, Executive Services, two (2) positions of Administrative Secretary to Council Representative II.

Section 2. That pursuant to Section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on August 7, 1980, the two (2) Council Representative II positions are hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified positions created in Section 1 hereof, the salary rate set forth in Salary Rate 7.3 of the Table of Classifications and Standard Salary Rates under Managerial Category, identified as Exhibit C to Ordinance No. 15268 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
