AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065) FOUR (4) PROFESSIONAL AND TWO (2) SUBPROFESSIONAL POSITIONS ON A LIMITED STATUS; TRANSFERRING THE SUM OF \$129,126 WITHIN THE GENERAL FUND (100) FROM THE UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065) FOR PERSONAL SERVICES AND RELATED NONPERSONAL SERVICES EXPENSES FOR THE ABOVE POSITIONS FOR A PERIOD OF NINE (9) MONTHS.

WHEREAS, in December 1979, the City Council authorized the City Manager and Planning Director to submit a grant application to the California State Coastal Commission; and

WHEREAS, the California State Office of Planning and Research, pursuant to Government Code Section 34200, has agreed to provide planning assistance for the Coastal Program; and

WHEREAS, the California Coastal Commission approved a financial grant in the amount of \$197,807 to prepare local coastal plans; and

WHEREAS, the original work program consisted of preparing land use plans and processing local coastal programs for nine coastal communities, and preparing implementing ordinances for three coastal communities; and

WHEREAS, The City of San Diego has recognized the problems and issues that were identified during the issue identification portion of the Local Coastal Program processing; and

WHEREAS, existing Planning Department staff completed a portion of this program during FY 79-80 and these costs are to be reimbursed by the grant; and

WHEREAS, the Planning Department does not now have sufficient staff to complete the Grant requirements within the grant period; and

WHEREAS, it is deemed necessary and desirable to transfer at this time sufficient funds from the Unallocated Reserve to the Planning Department to pemit the hiring, on a limited basis, of four professional and two subprofessional personnel and also provide funds for related nonpersonal expense to enable compliance with the grant requirements, said funds to be reimbursed to the General Fund by the Grant; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby further amended by amending Document No. 00-15298-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 065, Planning Department, the following positions on a limited basis:

- 2.0 Assistant Planners
- 2.0 Associate Planners
- 2.0 Subprofessionals

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$129,126 within the General Fund 100 from the Unallocated Reserve (605) to the Planning Department (065) to be used solely and exclusively for Personal Services and related nonpersonal service expenses for the above positions, as more specifically set forth in the table of budget requirements attached hereto as Attachment A.

Section 3. That the Auditor and Comptroller be and he is hereby directed, during the progress and upon completion of the grant program and receipt of grant funds, to assure that the General Fund is reimbursed for the sum of money authorized as an advance herein.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
