AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 5, DIVISION 2 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 75.0202 RELATING TO RATES OF FARE FOR TAXICABS.

Section 1. That Chapter VII, Article 5, Division 2 of the San Diego Municipal Code be and it is hereby amended by amending Section 75.0202 to read as follows:

SEC. 75.0202 RATES OF FARE

Rates of fare for taxicabs shall be set in accordance with the type of service that the taxicab is providing.

[Subsections (a) through (f) remain the same.]

- (g) It shall be unlawful for any permit holder and/or driver of a taxicab to demand of a passenger a charge for hire which is greater than the current maximum rate approved by the City Council pursuant to Section 75.0202(a) of this Code.
- (h) It shall be unlawful for any permit holder and/or driver to demand of a passenger a charge for hire which is greater than the permit holder's fixed route or meter rate filed with the City Manager pursuant to Sections 75.0201 or 75.0202(b) of this Code; provided, however, that nothing in this Article shall preclude a permit holder or driver from agreeing with prospective passenger(s) to a rate of fare which is less than the permit holder's currently filed and posted rates of fare if the agreement is entered into in advance of the passenger(s) hiring the taxicab for the trip.

[Subsections (h) through (l) become (i) through (m).]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
