AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 26.17 TO CHANGE THE COMPOSITION OF THE
AGRICULTURAL BOARD.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter II, Article 6, of the San Diego
Municipal Code be amended by amending Section 26.17 to read as
follows:

SEC. 26.17 AGRICULTURAL BOARD

A. PURPOSE AND INTENT.

(No change to this subsection.)

B. AGRICULTURAL BOARD.

There is hereby created an Agricultural Board which shall consist of nine (9) members who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the Council. The Board shall include two members with academic agricultural credentials, three experienced farmers by profession (one to be a representative of row crop interests, one to be a representative of dairy or grazing interests, and one to be a representative of the tree or vine crop interests), an accountant, an attorney, a soils or hydraulic engineer, and a real estate broker. A representative from the City of Escondido may also be appointed to serve as an ex officio member of the Board.

The members shall serve two (2) year terms and each member shall serve until a successor is duly appointed and confirmed. The members shall be appointed in such a manner that the terms of not more than five (5) members shall expire in any year. The expiration date shall be January 1. During January of each year, the Mayor may designate one (1) member as Chairman; however, in the absence of such designation, the Board shall, on or after February 15, select from among its members a Chairman.

The Board shall adopt rules consistent with laws for the government of its business and procedures. The Board shall meet not less than once every six (6) months.

C. DUTIES AND FUNCTIONS.

(No change to this subsection.)

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
