
AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A PERMIT GRANTING PACIFIC TELEPHONE AND TELEGRAPH COMPANY THE RIGHT TO INSTALL AND MAINTAIN FACILITIES IN PORTIONS OF PUEBLO LOTS 1318 AND 1319.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized to execute a permit conveying to PACIFIC TELEPHONE AND TELEGRAPH COMPANY the right, for a period of fifteen (15) years, to install and maintain underground telephone facilities and the right to construct and maintain a road within City-owned portions of Pueblo Lots 1318 and 1319, for a consideration of \$1,700 a year, a copy of which permit is on file in the office of the City Clerk as Document No. 00-15371.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
