AN ORDINANCE AMENDING ORDINANCE NO. 15268 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" BY AMENDING EXHIBITS A AND B THERETO TO CREATE NEW CLASSES OF AUDIO VISUAL SPECIALIST AND POLICE RECORDS SUPERVISOR AND ESTABLISHING A SCHEDULE OF COMPENSATION THEREFOR.

WHEREAS, the Civil Service Commission, at its regularly scheduled meeting of September 11, 1980, considered and approved the creation of new classifications of Audio Visual Specialist and Police Records Supervisor in the classified service of The City of San Diego; and

WHEREAS, the Commission at that same September 11, 1980, meeting also considered and established schedules of compensation for the newly created positions; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15268 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" be and the same is hereby further amended by amending Exhibit B thereto to create and establish the classified positions of Audio Visual Specialist and Police Records Supervisor.

Section 2. As a schedule of compensation for the positions created in Section 1 above, the following standard rate numbers of the Table of Classes and Standard Rates are hereby adopted.

<u>Position</u>	<u>Standard Rate No.</u>
Audio Visual Specialist	23.4
Police Records Supervisor	69.8

Section 3. The position of Audio Visual Specialist shall be inserted in Exhibit B of Ordinance No. 15268 (New Series), as amended, under the general category of GRAPHICS, between the positions of Graphic Supervisor and Graphics Illustrator.

Section 4. The position of Police Records Supervisor shall be inserted in Exhibit B of Ordinance No. 15268 (New Series), as amended, under the general category of POLICE, between the positions of Police Range Supervisor and Evidence Technician.

Section 5. The Auditor and Comptroller is hereby directed to amend, as necessary, Exhibit A of Ordinance No. 15268 (New Series), as amended, by calculating and inserting in said Base Salary Table the following new rates:

<u>Rate</u>	<u>Range (Steps A-E)</u>
23.4	\$1,315-1,576 (monthly)
69.8	\$1,461-1,765 (monthly)

Section 6. Pursuant to Section 8 of Ordinance No. 15268 (New Series), as amended, the above newly created positions, with the concurrence of the Civil Service Commission and City Manager, shall be and are hereby designated to be eligible for regular rate overtime compensation and the Personnel Director is hereby directed to include said designation in the Personnel Manual of The City of San Diego.

Section 7. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES) AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" BY AMENDING EXHIBITS A AND B THERETO TO CREATE NEW CLASSES OF AUDIO VISUAL SPECIALIST AND POLICE RECORDS SUPERVISOR AND ESTABLISHING A SCHEDULE OF COMPENSATION THEREFOR.

This ordinance amends the annual salary ordinance by creating two new classes for inclusion in the classified service of the City of San Diego and establishing a rate of pay for each classification. The new classes are Audio Visual Specialist, to be included under GRAPHICS and Police Records Supervisor, to be included under POLICE. The new classes are designated eligible for regular rate overtime pay.
