OCT 281980

AN ORDINANCE AMENDING CHAPTER III, ARTICLE 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 35.0116B RELATING TO UTILIZATION OF REVENUES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 5, of the San Diego Municipal Code be and it is hereby amended by amending Section 35.0116B to read as follows:

## SEC. 35.0116 UTILIZATION OF REVENUES

[No amendment to Section A and its subparagraphs.]

- B. When the tax imposed pursuant to this Article is eight percent (8%), it shall be utilized as follows:
  - (a) Nine thirty-seconds (9/32) of all revenues collected by the City under this Article shall be used solely for the purpose of promoting the City of San Diego.
    - (1) The amount of the City's annual contribution to the San Diego Convention and Tourist Bureau shall be not less than \$100,000.
    - (2) Any remaining revenues available under this subparagraph (a) shall be used to support any program including but not limited to programs of the San Diego Convention and Tourist Bureau, designed to promote the City, as the Council may direct.

- (b) One-eighth (1/8) of all revenues collected by the City under this Article shall be deposited to the Transient Occupancy Tax Unappropriated Reserve Fund, which is hereby created. Money shall be expended from this fund only by an ordinance appropriating part or all of the fund for such purpose or purposes as the Council may direct. Such purpose or purposes may include but need not be limited to promotion of the City.
- (c) One-eighth (1/8) of all revenues collected by the City under this Article shall be deposited to the General Fund.
- (d) One-fourth (1/4) of all revenues collected by the City under this Article shall be used solely for the purpose of constructing a New Convention Facility and all related costs and shall be deposited to the Transient Occupancy Tax New Convention Facility Fund, which is hereby created. Money shall be expended from this fund only for such purpose or purposes as the Council may direct in connection with the New Convention Facility including, but not limited to, the design, construction, operation, maintenance or debt service of said New Convention Facility.
- (e) Seven thirty-seconds (7/32) of all revenues collected by the City under this Article shall also be deposited to the Transient Occupancy Tax New Convention Facility Fund to be used for the purpose of

constructing a New Convention Facility and all related costs. This money shall be expended from this fund only in the event that all other revenues are not sufficient for such purpose or purposes as the Council may direct in connection with the New Convention Facility.

(1) Any revenues defined under this subparagraph (e) which are determined to be in
excess of the amount required for construction
of the New Convention Facility shall be returned
to the Transient Occupancy Tax Unappropriated
Reserve Fund.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
