## ORDINANCE NO. O- 15382 (New Series)

AN ORDINANCE AUTHORIZING AN AGREEMENT WITH CHILDREN'S HOSPITAL-SAN DIEGO AND AN INDENTURE WITH A CORPORATE TRUSTEE IN CONNECTION WITH THE ISSUANCE OF INSURED HOSPITAL REVENUE BONDS IN A PRINCIPAL AMOUNT NOT EXCEEDING \$17,000,000 AND FOR A TERM NOT EXCEEDING FORTY (40) YEARS, SUBJECT TO COUNCIL APPROVAL OF THE TERMS AND CONDITIONS THEREOF.

WHEREAS, The City of San Diego (the "City") has on November 13, 1979 enacted Ordinance No. 15074 (New Series) establishing a procedure for the issuance of hospital revenue bonds for the purpose of providing financing to certain health institutions located within the city; and

WHEREAS, the City has determined it is necessary and essential and a proper purpose and municipal affair to issue such bonds to finance a project at Children's Hospital--San Diego; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager and other proper officers of the City are authorized to prepare and to enter into, for and in the name and on behalf of the City, in accordance with the provisions of the San Diego Health Facility Revenue Bond Law, an agreement or agreements with Children's Hospital—San Diego (the "Hospital") providing for a loan by the City to the Hospital to be funded by the issuance of hospital revenue bonds by the City in a principal amount not to exceed

\$17,000,000 and for a term not to exceed forty (40) years, and an indenture between the City and a corporate trustee setting forth the terms of said bonds and providing for the payment and security thereof, and all necessary and appropriate documents in connection therewith; provided, however, that the final form of said agreement or agreements and of said indenture shall be submitted to the Council for approval by resolution prior to their respective execution by the City.

Section 2. This ordinance shall take effect on the thirtieth day from and after its passage.
