AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED BY RECLASSIFYING WITHIN DEPARTMENT 015 (PROGRAM 01540) ONE (1.00) ENDOWMENT OFFICER POSITION TO GRANTSEARCH COORDINATOR; EXEMPTING SAID POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Department of Intergovernmental Relations (015) is presently authorized two (2) Endowment Officer positions and

WHEREAS, a review of the position in Program 01540 indicates the nature and duties are more consistent with the classification of Grantsearch Coordinator; and

WHEREAS, Section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Department has requested the position contained in Program 01540 be reclassified as Grantsearch Coordinator and exempted from the Classified Service; and

WHEREAS, the Civil Service Commission has reviewed this request on November 14, 1980, and commented favorably upon the reclassification and exemption; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said reclassification. NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-1, as adopted and amended therein, by reclassifying within the personnel authorization schedule of Department 015, Department of Intergovernmental Relations, one (1) position of Endowment Officer in Program 01540 to Grantsearch Coordinator.

Section 2. That pursuant to Section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on November 14, 1980, the Grantsearch Coordinator position is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in Section 1 hereof, the salary rate set forth in Salary Rate 7.4 of the Table of Classifications and Standard Salary Rates under Managerial Category, identified as Exhibit C to Ordinance No. 15268 (New Series), be and the same is hereby adopted.

Section 4.. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16. 17 and 71 of the Charter of The City of San Diego.
