AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.0502 RELATING TO RIGHT OF APPEAL TO CITY COUNCIL.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 5, of the San Diego Municipal Code be and it is hereby amended by amending Section 33.0502 to read as follows:

SEC. 33.0502 RIGHT OF APPEAL TO CITY COUNCIL

The applicant, licensee, permittee and the Chief of Police shall have the right to appeal the hearing officer's decision pursuant to this Article to the Public Services and Safety Committee of the City Council. When a permit or license authorized under the provisions of this Article is granted, denied, suspended or revoked by the hearing officer, that decision shall be the final administrative remedy unless an appeal to the Public Services and Safety Committee is filed in writing with the City Clerk within ten (10) days of receipt of the hearing officer's written decision. When an appeal is filed with the City Clerk, it shall be placed on the Public Services and Safety Committee agenda for the

limited purpose of determining whether the Committee will hear the appeal. The Committee will accept an appeal for hearing when any of the following situations are found to exist:

Paragraphs (1), (2), (3), (4), (5) and last paragraph remain the same.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
