AN ORDINANCE AMENDING CHAPTER VI, ARTICLE I,
DIVISION 3 OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 61.0310 RELATING TO
PARTICIPATING AGENCY.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. This amendment is declaratory of existing law, and is adopted in order to make it clear that the law does not now preclude, and has not previously precluded, The City of San Diego from being a "participating agency" pursuant to the terms and conditions of the San Diego Improvement District Procedural Ordinance.

Section 2. That Chapter VI, Article 1, Division 3 of the San Diego Municipal Code be amended by amending Section 61.0310 to read as follows:


SEC. 61.0310 "PARTICIPATING AGENCY"

"Participating Agency" means any local, state or national agency or authority including but not limited to The City of San Diego and the U.S. Corps of Engineers.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
