AN ORDINANCE AMENDING ORDINANCE NO. 15268 (NEW SERIES).  
AS AMENDED. ENTITLED "AN ORDINANCE ESTABLISHING A  
SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF  
THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" BY  
AMENDING EXHIBIT C THERETO TO CREATE THE NEW CLASS OF  
GRANTSEARCH COORDINATOR AND ESTABLISHING A SCHEDULE  
OF COMPENSATION THEREFOR.

WHEREAS, the Civil Service Commission, at its regularly  
scheduled meeting of November 14, 1980, considered and approved  
the creation of the new classification of Grantsearch Coordinator  
in the service of The City of San Diego. and

WHEREAS, the Commission at that same November 14, 1980.  
meeting also reviewed and commented favorably, pursuant to Charter  
Section 117(a)17, for the exemption of said classification from  
the Classified Service of The City of San Diego: and

WHEREAS, there was also established a schedule of compensa-  
tion for the newly created position; NOW, THEREFORE.

BE IT ORDAINED. by the Council of The City of San Diego.  
as follows:

Section 1. That Ordinance No. 15268 (New Series), as amended.  
entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR  
OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL  
YEAR 1980-81" be and the same is hereby further amended by amending  
Exhibit C thereto to create and establish the position of  
Grantsearch Coordinator in the Managerial ranks.


Section 2. That pursuant to Section 117(a)17 of the City Charter, the Civil Service Commission, after reviewing said position and commenting upon it favorably, hereby approves and forwards to the City Council for final approval exemption from the Classified Service for said position.

Section 3. As a schedule of compensation for the position created in Section 1 above, the salary rate number of 7.4 of the Base Salary Table is hereby approved and assigned said position.

Section 4. The position of Grantsearch Coordinator shall be inserted in the Classification Range of Managerial B contained in Exhibit C with Salary rate 7.4 attached.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 15268 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1980-81" BY AMENDING EXHIBIT C HERETO TO CREATE THE NEW CLASS OF GRANT-SEARCH COORDINATOR AND ESTABLISHING A SCHEDULE OF COMPENSATION THEREFOR.  
This ordinance amends Exhibit C to the Annual Salary Ordinance by establishing the classification of Grantsearch Coordinator in the Unclassified Service. The Civil Service Commission voted favorably on November 14, 1980, to exempt the position from the Classified Service pursuant to Charter Section 17(a)(7). The position replaces a presently authorized Chief of Endowment Officer in the Department of Intergovernmental Relations. No additional funds are required due to salary savings in the department. The salary rate of 7.4 is assigned to the position in the Managerial category.
