AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY EXEMPTING FROM THE CLASSIFIED SERVICE COUNCIL REPRESENTATIVE POSITIONS IN CITY COUNCIL DEPARTMENTS 02300, 02400, and 02800.

WHEREAS, City Council Departments--Districts 3, 4 and 8 are presently authorized several Council Representative I and II positions; and

WHEREAS, Section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, a review of five of those positions (as enumerated hereinafter) indicates the nature and duties of those five positions are consistent with the unclassified criteria set forth in Charter Section 117(a)17; and

WHEREAS, it is now requested that those positions be exempted from the Classified Service pursuant to the Charter provisions; and

WHEREAS, the Civil Service Commission has reviewed this request on November 24, 1980, and commented favorably upon the exemptions; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said exemption; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to Section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on November 24, 1980, the following Council Representative II positions are hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego:

Council District 3 -- One (1) Council Representative II

Council District 4 -- Three (3) Council Representatives I

Council District 8 -- One (1) Council Representative I

Section 2. That Ordinance No. 15298 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-15298-1, as adopted and amended therein, by reflecting said exemptions within the personnel authorization schedule of Departments 02300, 02400, and 02800.

Section 3. The compensation heretofore established for said positions enumerated in Section 1 hereof shall remain the same as is authorized and reflected in the fiscal year 1980-81 annual appropriation ordinance and Exhibit C to Ordinance

No. 15268 (New Series), the City of San Diego annual salary ordinance, it being the intention of this ordinance to effectuate classified service exemption only.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
