AN ORDINANCE AMENDING ORDINANCE NO. 15298 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE CLERK'S DEPARTMENT (03500) ONE (1) ASSOCIATE ADMINISTRATIVE ANALYST TO SERVE AS AN ASSISTANT ELECTIONS OFFICER; TRANSFERRING THE SUM OF \$14,000 WITHIN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO THE CITY CLERK'S DEPARTMENT (03550) FOR PERSONAL SERVICES AND OVERHEAD FOR THE ABOVE POSITION FOR THE REMAINDER OF THE FISCAL YEAR 1981.

WHEREAS, election activity has increased significantly; and

WHEREAS, there is an ever increasing number of statutes, regulations and decisions to which the City elections must conform; and

WHEREAS, it is imperative that the City respond in a timely, accurate and meaningful manner to all questions involved in elections; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 15298 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1980-81 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby further amended by amending Document No. 00-15298-1, as adopted and amended therein, by adding to the personnel authorization

schedule of Department 03500, City Clerk's Department, one (1) Associate Administrative Analyst for assignment to Elections Program (03550).

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$14,000 within the General Fund 100 from the Unallocated Reserve (605) to the City Clerk's Department 03500 to be used solely and exclusively for personal services and overhead expenses for the above position for the remainder of the fiscal year 1981.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


