That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$14,000 within the General Fund 100 from the Unallocated Reserve (605) to the City Clerk's Department 03500 to be used solely and exclusively for personal services and overhead expenses for the above position for the remainder of the fiscal year 1981.
