AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 2, OF
THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION
82.07 RELATING TO PARKING VIOLATIONS.

WHEREAS, an increased traffic volume and a lack of adequate off-street parking facilities have created hazardous conditions in many congested areas of the City; and

WHEREAS, said conditions have created a need for more vigorous enforcement of parking regulations and increased penalty fees for violations of the regulations; and

WHEREAS, the State has imposed a surcharge of \$1.50 to be remitted to the County Treasurer for each parking citation fee collected by the City effective January 1, 1982; and

WHEREAS, delayed payment of parking citations has resulted in referral of those citations to the Department of Motor Vehicles and/or preparation of formal complaints against the violators; and

WHEREAS, the costs incurred by the City for said procedures are not presently recovered; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 82.07 to read as follows:


