BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF SERRA MESA PARK AND RECREATION CENTER SAFETY IMPROVEMENTS -

PHASE 1.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$4,000.00 from CIP 23-248, SERRA MESA COMMUNITY PARK IMPROVEMENTS, Park Service District Fund 11390 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that CIP 23-248, SERRA MESA COMMUNITY PARK IMPROVEMENTS is hereby amended to include the reconstruction of an existing stairway adjacent to the multi-purpose sports field and to provide new stairway lighting.
