

RESOLUTION No. R-250920 (R-80-1067)


Adopted on JAN 7 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of HARRY L. SUMMERS, INC., a California corporation, executed in favor of The City of San Diego, bearing date of November 16, 1979, conveying to said City a permanent easement and right-of-way for a public street, and incidents thereto, over, under, upon, along and across all those portions of Pueblo Lots 1278 and 1303 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for public streets, and the same is hereby named AVENIDA LA BAHIA and AVENIDA NAVIDAD.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
