APPROVING MAP OF SKYVIEW HOMES

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by ALLEN D. RING, a Registered Civil Engineer, entitled "SKYVIEW HOMES Being a subdivision of portion of the south 1-1/2 acres of the north 2 acres of the east half of Lot 8, and part of the north half acre of the east half of Lot 8 and a portion of the south 72 feet of the east half of Lot 10 of Cave and McHatton's subdivision, according to Map thereof No. 159, filed in the office of the County Recorder of said San Diego County, March 30, 1887, together with a portion of Newcastle Street and a portion of 61st Street as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Newcastle Court for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the

construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
