WHEREAS, it is proposed that a portion of Laurel Street between Home Avenue and the westerly line of O. D. Arnold Heights, Map No. 2924, be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That a portion of Laurel Street between Home Avenue and the westerly line of O. D. Arnold Heights, Map No. 2924, as more particularly referred to in Resolution of Intention No. R-250972 is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a portion of Laurel Street between Home Avenue and the westerly line of O. D. Arnold Heights, Map No. 2924, as more particularly shown on Drawing No. 14625-B on file in the office of the City Clerk as Document No. RR-250972 which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

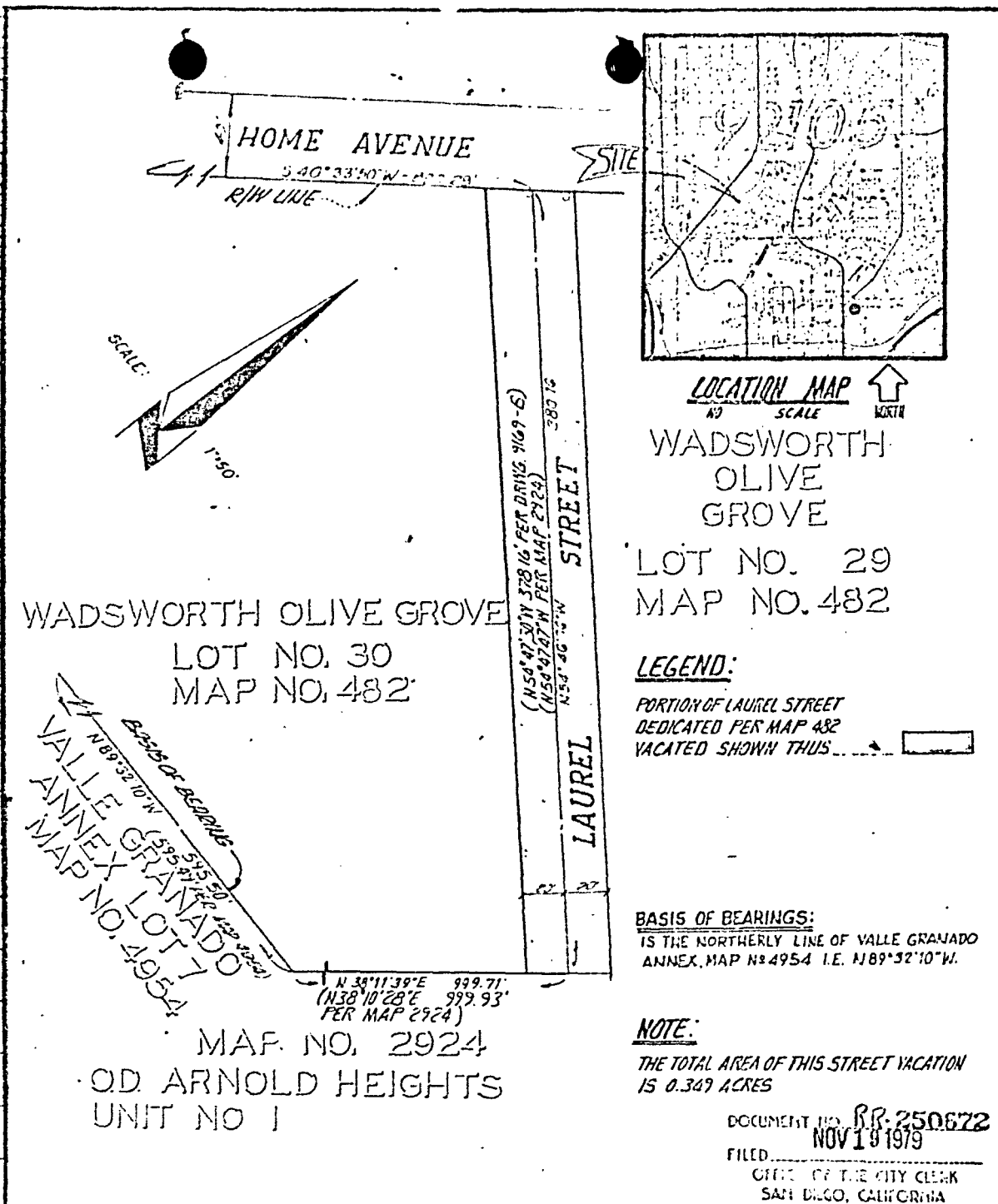
