

RESOLUTION No. R-250931 (R-80-1065)



WEST POINT LOMA BOULEVARD

That portion of Lot 26 in Block 32 of Loma Alta No. 2, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1082, filed in the Office of the County Recorder of San Diego County, August 29, 1907, more particularly described as follows:

Beginning at the Southwest corner of Parcel 1 of Parcel Map 7420, filed in the Office of the County Recorder of San Diego County on June 13, 1978 at File Page No. 78-245090. Thence along the Southeasterly prolongation of the Southwesterly line of said Parcel 1, South $47^{\circ}46'08''$ East, 5.88 feet; thence South $58^{\circ}47'47''$ West, 28.96 feet; thence North $47^{\circ}07'31''$ East, 27.86 feet, returning to the Point of Beginning.

Basis of Bearing is the Southwesterly property line of Parcel 1 of Parcel Map 7420, i.e., North $47^{\circ}46'08''$ West.
