

RESOLUTION NO. R-250933

JAN 7 1980

WHEREAS, The City of San Diego has been funded by Urban Mass Transit Administration (UMTA) to develop a plan for coordinating and/or consolidating existing social service agencies' transportation services; and

WHEREAS, this will be a joint project between the City, Comprehensive Planning Organization (CPO), and California Department of Transportation (CALTRANS); and

WHEREAS, the City Council, in Resolution No. 250385, authorized acceptance of UMTA funds to conduct this project during the period February 1980 to February 1981; and

WHEREAS, the Board of Directors of the Metropolitan Transit Development Board (MTDB) has offered to assist the above project by providing staff assistance and the sum of \$20,000 to fund the initial inventory of social service vehicles; and

WHEREAS, the inventory would be conducted by City, CALTRANS and CPO during the period January to April of 1980; and will provide information on number and condition of vehicles, funding sources, clientele eligibility, description of services and number of clients served; and

WHEREAS, the final product will be furnished to MTDB and other agencies and will provide a basis for the development of a coordination/consolidation plan for elderly and handicapped transportation services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Manager be and he is hereby authorized to execute an agreement with the San Diego Metropolitan Transit Development Board for the purpose of conducting a survey of transportation vehicles available to elderly and handicapped persons, pursuant to the terms and conditions of that certain agreement on file in the office of the City Clerk as Document No. RR- 250933.

2. That the City Manager is authorized to accept, for and on behalf of The City of San Diego, upon execution of said agreement, the sum of \$20,000 from MTDB, said funds representing fiscal assistance for conducting the above-mentioned survey.
