WHEREAS, City Council staff is now located on both the 10th and 11th floors of the City Administration Building (CAB); and

WHEREAS, said staff coordination is less effective and more time consuming because of the physical separation; and

WHEREAS, sufficient space is available on the regularly assigned Council floor (10th floor of CAB) to accommodate relocation of all City Council staff; and

WHEREAS, such accommodation will require remodeling of existing space on the 10th floor; and

WHEREAS, the City Clerk's office is redesigning floor space which would effectuate a greater and more effective use of existing space for personnel and equipment; and

WHEREAS, such redesign will require minor modifications to include moving wall partitions; and

WHEREAS, it is now deemed necessary and desirable to effect such remodeling and relocation of staff for better utilization of space and personnel; and

WHEREAS, it is further deemed necessary and desirable to have said remodeling accomplished by outside contract in order to meet time constraints; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that the City Manager be and he is hereby authorized and  
directed to take all necessary steps to advertize for bids for  
remodeling the 10th floor and the City Clerk's office on the  
12th floor, City Administration Building.
