


RESOLUTION No. R- 250958 (R-80-1116)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$183,383.00 by SAPPER BROTHERS INC., a corporation, for the CONSTRUCTION OF A RETAINING WALL ON THE SOUTH EAST SIDE OF TORREY PINES ROAD IN THE 2700 BLOCK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 767306.
2. That the City Auditor and Comptroller is hereby authorized to add CIP 52-274 to the FY 1980 Capital Improvements Program.
3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$226,700.00 from Disaster Assistance Fund 39024 to CIP 52-274.
4. That the expenditure of \$226,700.00 is hereby authorized from Disaster Assistance Fund 39024 CIP 52-274 of the City of San Diego solely and exclusively for providing funds for said project and related costs.
