BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. CARL BURGER'S DODGE WORLD; 2. EL CAJON FORD and 3. COURTESY CHEVROLET are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LIGHT DUTY TRUCKS AND VANS as follows:

1. CARL BURGER'S DODGE WORLD for Item 1 - fourteen (14) 1-ton cab and chassis (Dodge D300) for a cost of \$6,200.00 each for a total cost of \$86,800.00; Item 4 - two (2) medium vans (Dodge B300) for a cost of \$7,520.00 each for a total cost of \$15,040.00; Item 7 - one (1) light van (Dodge B200) for a cost of \$6,540.00; Item 8 - one (1) 1-ton cab and chassis for a cost of \$6,380.00; for a total cost of \$114,760.00; terms net 20 days plus sales tax;

2. EL CAJON FORD for Item 2 - six (6) 1-ton cab and chassis (Ford F350) for a cost of \$6,235.20 each for a total cost of \$37,411.20; Item 3 - One (1) light van (Ford E150) for a cost of \$6,093.00; Item 5 - one (1) window van (Ford E150) for a cost of \$6,376.57; for a total cost of \$49,880.77; terms net 15 days plus sales tax;

3. COURTESY CHEVROLET for Item 6 - two (2) step vans (Chevrolet CP 31042) for a cost of \$9,400.00 each for a total cost of \$18,800.00; terms net 20 days plus sales tax.
