

RESOLUTION NO. RR-250968 (R.80-1093)


WHEREAS, in 1971, certain property adjacent to Torrey Pines State Park was donated to the City of San Diego by Pardee Construction Company with the condition it be used for park purposes; and

WHEREAS, said property comprising of 13.78 acres is currently designated as Del Mar Hills Park and the State of California has requested that the City convey the property to the State to be included in the Torrey Pines State Reserve; and

WHEREAS, said property will be transferred with a provision restricting its use to park purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that, pursuant to Section 22.0907 of the Municipal Code, the Mayor and the City Clerk are hereby authorized and empowered to execute a grant deed to the State of California, a copy of which is on file in the office of the City Clerk as Document No. RR-250968, in consideration for the State of California's obligation to limit the use of said property to public park and recreation purposes.
