BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT RESOLVED, that the addition of C.I.P. Project #37-147 - Paramedic Dispatch Frequency Phase I - to the fiscal 1980 C.I.P. program be hereby authorized.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$26,000 from C.I.P. Project #37-138 to C.I.P. Project #37-147.

BE IT FURTHER RESOLVED, that the expenditure of: \$129,000 from the Capital Outlay Fund #30245, \$19,000 from Water Revenue Fund #505, and \$6,000 from Sewer Revenue Fund 506, of The City of San Diego, be hereby authorized, solely and exclusively, for accomplishing the Radio Communications Systems Improvement Projects, Nos. 37-1470, 37-012 and 37-139.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to have performed by City forces the required work for the C.I.P. Radio Communications Systems Improvement Project Nos. 37-1470, 37-012 and 37-139 at various locations in The City of San Diego, to be accomplished incrementally during the fiscal year as materials are received; at a cost not to exceed \$70,000.
