BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$25,644.95 made payable to A & J CONSTRUCTION COMPANY in full settlement of all claims against The City of San Diego for repairs made to Our Lady of Sacred Heart Church.
