

ADOPTED ON JAN 17 1980

BE IT RESOLVED by the Council of the City of San Diego as follows:

1. That all bids theretofore received on November 16, 1979 pursuant to publication of notice calling for bids on THE IMPROVEMENT OF FIFTH AVENUE BETWEEN "E" AND "F" STREETS AND BETWEEN "J" AND "K" STREETS AND FIFTH AVENUE NORTH OF "E" STREET (GASLAMP QUARTER) are hereby rejected; and Resolution #250387 is hereby rescinded; and
2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE IMPROVEMENT OF FIFTH AVENUE BETWEEN "E" AND "F" STREETS AND BETWEEN "J" AND "K" STREETS AND FIFTH AVENUE NORTH OF "E" STREET (GASLAMP QUARTER), San Diego, California, filed in the office of the City Clerk of The City of San Diego, California on JAN 14 1980 and bearing official Document No. A 00033 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.


BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$936,300 from the Industrial Development Fund 30248 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for THE IMPROVEMENT OF FIFTH AVENUE BETWEEN "E" AND "F" STREETS AND BETWEEN "J" AND "K" STREETS AND FIFTH AVENUE NORTH OF "E" STREET (GASLAMP QUARTER).
