

RESOLUTION No. R- 250994 (R. 80-1183)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of HOBBS MARLOW, INC. and PALOS VERDES SHORES COMPANY, executed in favor of The City of San Diego, bearing date of September 11, 1979, conveying to said City the permanent easement and a right of way for a public street, and incidents thereto, through, over, under, upon, along and across all that portion of the southwest quarter of Section 35, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named FLANDERS DRIVE.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
