APPROVING MAP OF MIRA MESA WEST UNIT NO. 9 AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled
"MIRA MESA WEST UNIT NO. 9 Being a subdivision of a portion
of the Southeast Quarter of Section 35, Township 14 South,
Range 3 West, San Bernardino Meridian, in the City of San Diego,
County of San Diego, State of California, together with a portion
of Mira Mesa Boulevard, as dedicated to public use.," is made
in the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the following: Dabney
Drive, Gaston Drive, Dancy Road, Dancy Court, Feller Cove,
Adcock Lane, Flanders Place and a portion of Mira Mesa Boulevard
for public purposes; and said streets and portion of a street
are hereby declared to be public streets and a portion of a
public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Mira Mesa
Boulevard, adjacent and contiguous to Lots 1237 through 1255;
and in and to Parkdale Avenue, adjacent and contiguous to
Lots 1255, 1256 and 1264, all as shown on this map within this
subdivision.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, as granted and shown on this map, are accepted on behalf of The City of San Diego, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, PARDEE CONSTRUCTION COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MIRA MESA WEST UNIT NO. 9.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
