

RESOLUTION No. R-251008 (R-80-1145)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of BALMAC INC., a California corporation, executed in favor of The City of San Diego, bearing date of September 13, 1979, conveying to said City an easement for public street purposes over, along and across all that portion of Lot 50 of the Highlands, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named DAGGET STREET.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
