BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$5,000 within the Capital Outlay Fund 245 from Unallocated Reserve to CIP 20-001 Minor Improvements.

BE IT FURTHER RESOLVED, that the expenditure of \$5,000 from the Capital Outlay Fund #30245, of The City of San Diego, be hereby authorized, solely and exclusively, to purchase four soccer goals for the KGB Soccer Field in Balboa Park.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller, be hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.




