

RESOLUTION NO. R-251023

WHEREAS, the State Legislature in 1972 mandated state-wide 9-1-1 to be funded by a telephone surcharge and on September 14, 1979, the City received approval of its 9-1-1 plan from the State Department of General Services; and

WHEREAS, on October 9, 1979, the City Council adopted Resolution No. 250391 authorizing the City Manager to proceed with the implementation of the 9-1-1 emergency dialing system as mandated by the State of California, contingent on a commitment of the State to fund the program costs for a basic system with selective routing; and

WHEREAS, the State of California has assured the City Manager that the State will pay all telephone costs related to implementation of the 9-1-1 emergency dialing system; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to place an order with Pacific Telephone Company for the telephone equipment necessary for implementation of a 9-1-1 emergency dialing system.
