WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Harry F. Haas	Police	\$ 810	Mr. Haas is a Police Officer. One year ago he earned a partial award of \$190 for his suggestion to establish a fee for processing vehicle-for-hire applications. One year's experience has shown an increase in revenue of \$14,600. This is the remainder of his award.
William C. Pontsler	General Services	\$ 600	Mr. Pontsler is an Electrical Supervisor in the Buildings Division. One year ago he earned a partial award of \$400 for his suggestion to use watt miser fluorescent lamps in City buildings. One year's experience has shown an energy savings of \$11,489. This is the remainder of his award.
Larry L. Griffin	Police	\$ 280	Mr. Griffin is a Police Officer. He suggested that a system of scheduled, periodic inspections of taxicabs be established. Since operators will be required to bring their vehicles to a central location for examination, significant time savings are expected. Estimated savings are \$5,603 annually. This is a partial award pending a final 12-month review.
Daniel Karsh	Police	\$ 140	Mr. Karsh is a Sergeant. One year ago he earned a partial award of \$110 for his suggestion to decrease the frequency of reading communications monitoring meters. One year's experience has shown a savings of \$2,478. This is the remainder of his award.
