WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Charles R. Johnson	Library	\$ 80	Mr. Johnson is a Senior Typist. One year ago he earned a partial award of \$50 for his suggestion to redesign microfilm camera baseboards to include overdue book instructions in the picture frame. One year's experience has shown a total savings of \$1,314. This is the remainder of his award.
Harry F. Haas	Police	\$ 75	Mr. Haas is a Police Officer. One year ago he earned a partial award of \$100 for his suggestion to increase the fee charged for vehicle-for-hire licenses. One year's experience has shown a total increase in revenue of \$1,729. This is the remainder of his award.
Mary E. Walker	Fire	\$ 55	Ms. Walker was an Intermediate Typist at the time of her suggestion. One year ago she earned a partial award of \$50 for her suggestion to discontinue the Fire Department's internal maintenance of payroll sheets. One year's experience has shown a total savings of \$1,072. This is the remainder of her award.
Linda H. Knarreborg	City Clerk	\$ 55	Ms. Knarreborg is an Intermediate Clerk. She suggested that the policies for processing property bid proposals be revised. This change both saves \$568 annually and improves service to the public.
Thomas C. Feldscher	Fire	\$ 30	Mr. Feldscher is a Firefighter. He suggested that a new brand of goggle be purchased that both saves money and improves eye safety. Savings were \$214. This was considered to be a significant safety improvement.
