WHEREAS, The City of San Diego is the owner of easements for access road, landfill and waterline purposes affecting Lot 1 of City of San Diego Industrial Park Unit No. 6, Map No. 6292; and

WHEREAS, it is requested that the City quitclaim to COLLINS DEVELOPMENT COMPANY, a California corporation, and KEARNEY MESA ASSOCIATES, a California general partnership, its interest in and to said easements; and

WHEREAS, the owners of the property wish to clear title to their property; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City desires to negotiate the sale of said easements to COLLINS DEVELOPMENT COMPANY, a California corporation, and KEARNEY MESA ASSOCIATES, a California general partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to the City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property, as determined by Property Department staff, is the sum of Four Hundred Fifty Dollars (\$450); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. RP-251044, be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the sum of Four Hundred Fifty Dollars (\$450) to COLLINS DEVELOPMENT COMPANY, a California corporation, and KEARNEY MESA ASSOCIATES, a California general partnership.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
