BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to expend Community Development Block Grant (CDBG) funds in an amount not to exceed \$7,020, solely and exclusively for the above purpose.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$7,020 from Fund 18515, organization 5951 (contingencies) to Fund 18515, organization 5916 (Inner-City Self Help Project).
