BE IT RESOLVED, by the Council of The City of San Diego as follows:


Pursuant to authority conferred by and in accordance with the provisions of Section 82.19 of the San Diego Municipal Code, the following streets in said City be, and they are hereby declared to be ONE-WAY STREETS:

13TH STREET between "C" Street and Imperial Avenue, for one-way southerly-bound traffic;

14TH STREET between National Avenue and "C" Street, for one-way northerly-bound traffic.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be, and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
