

RESOLUTION NO. R-251064 (R.80-1150)  
JAN 28 1980

WHEREAS, on October 21, 1976, the City Council authorized the City's execution of a Memorandum of Understanding between the City, International Boundary and Water Commission and Army Corps of Engineers for the acquisition of a right of way for the Tia Juana Flood Control Project and the Memorandum provided for the City to acquire all rights of way for the project and contribute \$600,000 toward acquisition costs; and

WHEREAS, the Memorandum also provided for IBWC and the State of California Department of Water Resources to reimburse the City for the costs in excess of \$600,000 and advance funds in that amount of \$2,666,188 for reimbursement were later approved; and

WHEREAS, cost estimates for the project which included \$2,796,263 for land acquisition and \$67,705.21 for incidentals were approved by Council on June 6, 1978 and said estimates set the funds appropriated for land acquisition and incidentals at those amounts; and

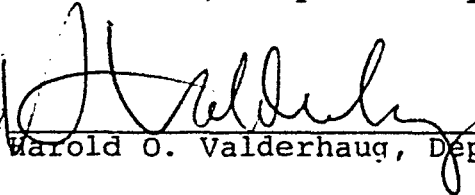
WHEREAS, it is estimated that an additional \$1,500,000 may be necessary to complete the land acquisition, which must be paid for court awards under condemnation proceedings previously authorized, out of court settlements and administrative expenses; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of \$1,500,000 for land acquisition and all administrative and incidental expenses related to the

Tia Juana Flood Control Project, to be funded by reimbursements from the U. S. International Boundary and Water Commission, State of California Department of Water Resources, and interest collected by the City from funds deposited in Superior Court for condemnation proceedings on said project, is hereby authorized and approved.
