WHEREAS, no in-depth review of said ordinances has been effected since their original adoption; and

WHEREAS, the District Attorney of San Diego County has proposed the formation of a joint City-County task force to conduct a thorough study of the ordinances and to review their operation; and

WHEREAS, said proposed task force includes a member of the City Council selected by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Councilman Larry Stirling is hereby appointed as the City Council's representative to the District Attorney's Task Force for Review of the Campaign Control Ordinance.
