WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Vincent J. Marchetti Floyd R. Moore	Park and Recreation Engineering and Development	\$1000	Mr. Marchetti is a Project Officer II in the Park Development Division, and Mr. Moore was an Assistant Civil Engineer at the time of this suggestion. They suggested that the procedure for processing bids for Capital Improvement Projects be revised. This saved an estimated \$43,204 in construction costs alone during the five and a half month trial period.
Caroline L. Steyers	Building Inspection	\$ 300	Ms. Steyers is a Senior Engineering Aide. She suggested that the permit issuance counter be reorganized. Not only does this save \$2,543 annually, but it also provides much faster service to the public.
Charles E. Lundy James Cerone	Water Utilities	\$ 260	Mr. Lundy and Mr. Cerone are Welders in the Systems Division. They suggested that a radialgraph burning machine be purchased to reduce the time it takes to make meter cover parts. This is expected to save \$5,253 annually. This is a partial award pending a final 12-month review.
