WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Nina L. Ladd	Police	\$ 70	Ms. Ladd is a Senior Clerk. One year ago she earned a partial award of \$45 for her suggestion to revise the fee schedule for Police Department photographs. One year's experience has shown a total savings of \$1,150. This is the remainder of her award.
Richard Bono George Jessup	Fire	\$ 50	Mr. Bono and Mr. Jessup are Firefighters. They suggested that stethoscopes be added to Fire Department emergency first aid kits. This was considered to be a significant safety improvement.
Gary W. Learn	Police	\$ 50	Mr. Learn is a Sergeant. He developed a training course to improve the quality of Police Department photographs. This is expected to produce significant savings. This is a partial award pending a final 12-month review.
Vincent DeLeva	General Services	\$ 25	Mr. DeLeva is an Electrician in the Communications and Electrical Division. He suggested that water bill mailers be used to enlist citizen aid in reporting burned out street lights. This was considered to be a significant operational improvement.
Wilmore McDowell	Park and Recreation	\$20	Mr. McDowell is a Gardener in the Park Division. He suggested that certain irrigation head spray patterns be modified to prevent clogging. Pop-up irrigation heads were installed. This was considered to be a significant operational improvement.
